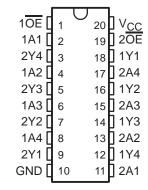

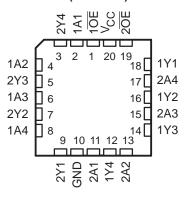

SN54F240 . . . J PACKAGE SN74F240 . . . DB, DW, OR N PACKAGE (TOP VIEW)



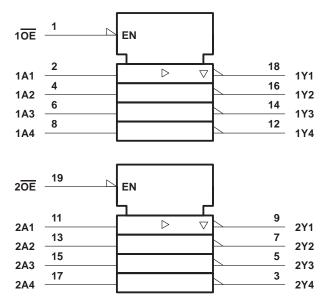
SN54F240 ... FK PACKAGE (TOP VIEW)

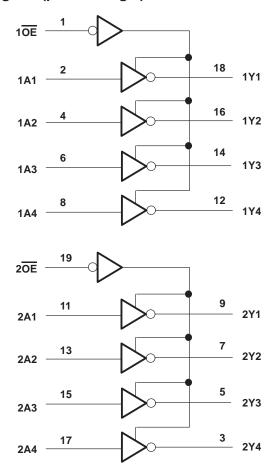
